# 8. Treasurer's Report:

Chris Negvesky provided an update on the finances from February:

• We had deposits of \$6,960.00 in February for Homeowners dues, an estoppel of \$100.00 and bank interest of \$0.49

- We had bills in February of \$25.40 for Duke Energy, \$487.15 for the website and email hosting, \$351.96 for A-Stellar and \$256.80 for the UPS store
- The savings account has a total of \$20,005.08 and the two checking accounts \$12,289.41 and \$12,618.31, resulting in a total equity of \$44,912.80.
- New bills coming in are: Duke, A-Stellar and Insurance policy of \$669.00

Motion to accept Treasurer's Report for February by Steve Kansagor Second – Kim Branch. All in favor and none opposed

Chris Negvesky provided an update on the finances from March:

- We had deposits of \$1,160.00 in March for Homeowners dues, interest on dues of \$3.90, bank interest of \$0.57 and the neighborhood grant of \$250.00. This brings total income for the month to \$1,414.47.
- Bills were Duke, A-Stellar and Insurance policy
- The savings account has a total of \$30,005.52 and the two checking accounts \$1,413.92 and \$13,861.19, resulting in a total equity of \$45,280.63.
- As of April 11, all dues have been paid except for four households
