 - Kim Branch motions to approve minutes from 04/13/19. Steve Kansagor seconds. All in favor and none opposed
 - Chris Negvesky motions to approve 05/11/19 minutes. Steve Kansagor seconds. All in favor and none opposed.

5 President's Report

- Russell Smith and Walter Johnson went through the neighborhood this week. A couple violations that will require letters to go out
- Russell Smith reached out to the resident from 2676 Redford Court West about the vehicle parked. Russell Smith also texted her as well and CCed Walter Johnson. She did not respond, so the letters have been passed on to the attorney to contact her
- 2674 Meadow Wood Drive had garbage cans out again. A letter will be go out informing them about the violation
- There was a sign put up on a house on Northridge asking people to pick up their dog feces. We will need to remind the homeowners that we aren't allowed any signs on properties here
- Reminder that we changed the August meeting to August 17th. We also don't have a meeting in July
- There were questions that came up and complaints about the Police vehicle parked on Northridge. According to Florida Statute 320.01(26), a "Commercial Motor Vehicle" is a vehicle not owned by the government, with a Gross Vehicle Weight (GVW) of 26,001 lbs. or more, or has three or more axles regardless of weight, or is used in combination (vehicle plus trailer) when the weight of such combination exceeds 26,001

 - 5 residents still haven't paid their dues yet. They are:
 - Resident on Beaumont Ct W
 - x2 Residents on Brattle Ln
 - x2 Residents on Saxony Ct W
 - We have over \$35,000 in cash on hand. Chris Negvesky suggested we get a CD for \$20,000 to start incurring interest.
 - Walter Johnson suggested we do two \$10,000 CDs, in case we need to liquidate one prematurely
 - Discussed two \$10,000 CDs (\$20,000 total), one with a longerterm commitment and one short term
 - Kim Branch motions to set up two \$10,000 CDs. Steve Kansagor seconds. All in favor and none opposed
 - Steve Kansagor asked the question of what we do for next year, if we are looking at having over \$40,000 in cash
 - Russell Smith reminded group that we decided to maintain the dues at \$145 in case we needed to replace the entire well systems
 - In the December meeting, we can propose a reduction of dues so we are breaking even on regular expenses.
 - Our covenence limits us to increasing the dues no more than 15% each year
 - Russell Smith and Chris Negvesky will get in touch with our attorney to find out if we can offer a discount on early payment for dues paid next year.
 - Payments totaling \$374.95 were made. \$22.99 Duke Energy, \$351.96 for landscaping
 - Bank account 7090 has \$7,093.43, Account 6851 has \$7,919.21 and Account 7146 has \$20,001.32 on account
